## The Application Process

1kbw is no longer within the Pupillage Gateway system although our applications procedure follows the Pupillage Gateway summer timetable.

## The Interview

The best candidates will be invited for an interview conducted by a panel representing a cross-section of members of chambers. No prior preparation or written work is required, and undertaking a mini-pupillage with us is not a prerequisite to a successful application.

## During Pupillage

Your pupillage at 1kbw will be exclusively in family law. We offer two pupillages a year, each lasting 12 months. Each pupil will receive an award of £22,500 during the first six months and will retain any earned income during the second six months. Our pupils do not pay rent, clerks' fees or travel expenses.

Each pupil will have three pupil supervisors during their pupillage.

We proactively try to recruit our tenants from our pupils. In the last decade we have offered tenancy to 17 of the 20 pupils in chambers.

# Who should apply?

We look for pupils with excellent academic ability and personal attributes.

Applicants must have at least a 2:1 degree, and in addition demonstrate a commitment to the Bar, an impressive academic or employment history, and an interest in the particular specialisms of chambers.

Our successful candidates tend to be confident, articulate and interesting individuals with the right aptitude for life at the Bar.
