Of a total workforce of 75, 68 responses were received equating to a 91% response rate. We had a 92% response rate from the staff team and a 90% response rate from members of chambers. This was a large increase on the previous 2017 survey.


The results are based on responses received from those who participated therefore they may not reflect the entire organisation.
