Workshop 1 ———

Local Authorities, Parental Responsibility and Duties of Care

Speaker: Victoria Green

• There are many decisions that local authorities make for looked after children under their parental responsibility. But, where are the boundaries, and what are the implications of parental responsibility when it comes to a duty of care? What decisions can a local authority make without a parent's agreement, and when does there need to be agreement or an order from the court? This talk will explore some of the issues that can arise.

Unregistered Placements

• The shortfall in the availability of secure accommodation for children remains, meaning that the authorisation of children within unregistered placements is still a common occurrence. This talk will cover the practical and legal points relating to the placement of children in unregistered placements. What are the key issues when dealing with an application involving a child being placed in an unregistered placement? What is the best practice that should be complied once the placement has been authorised?

FDAC: Suitability, scope and success Speaker: Andrea Watts

• The FDAC model has led to positive outcomes for many families since its inception, but what is it that makes FDAC successful when standard care proceedings might have yielded a different result? What factors determine whether a family can go into FDAC, and what can be done to replicate the FDAC process in those cases where it is not an option? This talk will consider the recent developments in this area and offer practical tips to manage similar cases.

Older children and applications for public law orders Speaker: Lucinda Ferguson

• The care of older children, especially those aged 16 and 17, raises particular problems for local authorities and the courts. Local authorities are increasingly being criticised by the courts and in public policy discourse for misusing section 20 agreements. But when should a local authority apply for an interim care order 'vs' make use of a section 20 agreement for a child just about to turn 17? When should care proceedings continue after a child turns 17? What is the impact on these issues of the child's capacity?

Lucinda is an associate member of chambers alongside her roles as Associate Professor of Family Law at the University of Oxford and Tutorial Fellow in Law at Oriel College, Oxford. Lucinda is a specialist in family law and education law and has advised and acted at all levels up to and including the High Court.

• Every Local Authority risks potentially unlimited exposure to the costs of securing the 'welfare' of a child such as one who is taken into their care, needs to be housed, or educated during an application for summary return under The Hague Convention 1980. The wide ranging powers of the courts in such circumstances may be a very valuable resource for parents as well as children and any appointed Guardian.
